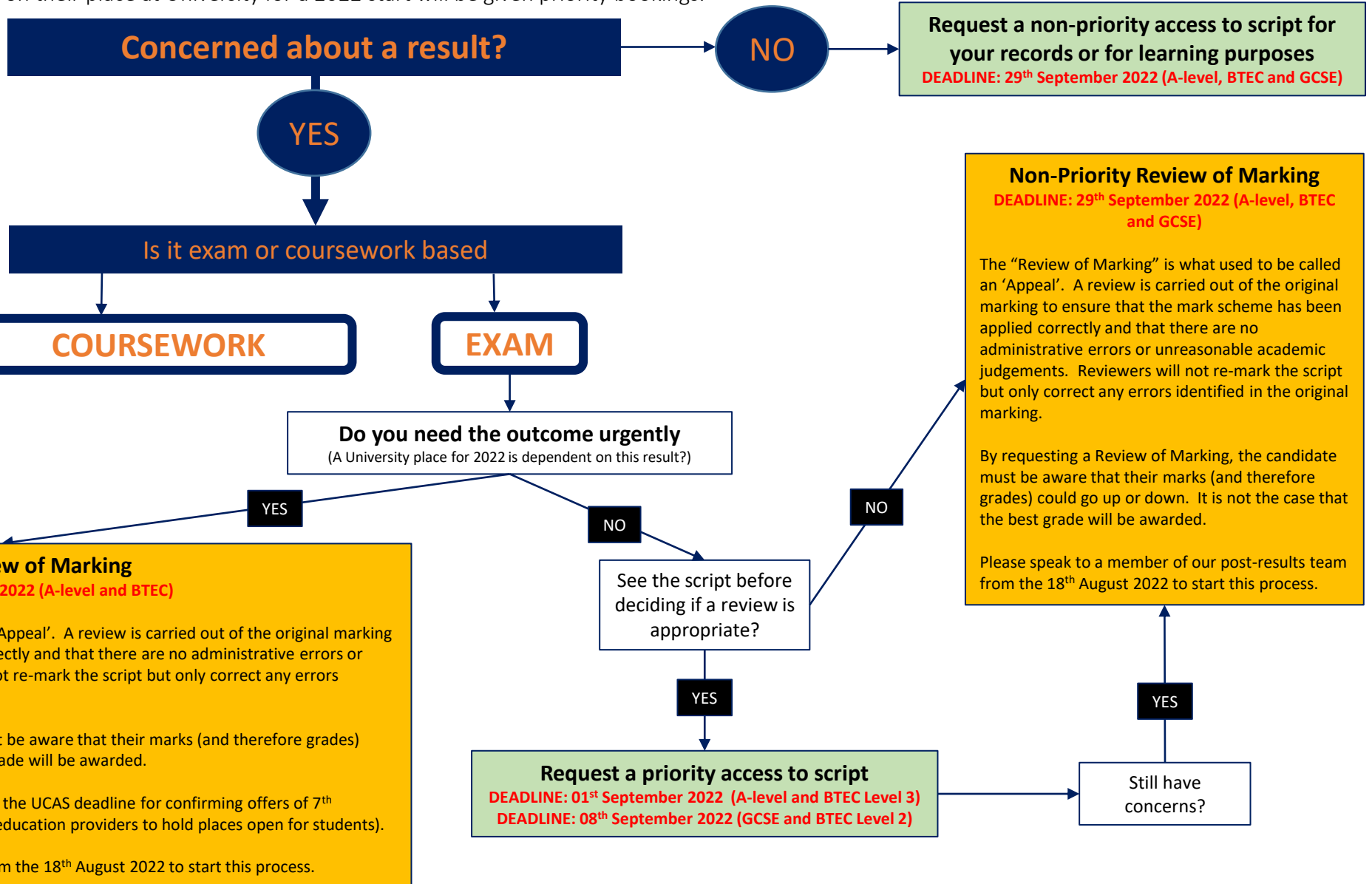

## A-LEVEL, EPQ & GCSE COURSEWORK

The exam boards prevent us from reviewing the marking of any A-level, EPQ or GCSE coursework at this stage. A review of moderation process was available when the marks were released to students in April/May 2022 if students wished to question their internally moderated marks which were sent to the exam board.

An outcome of the review of moderation is due before the UCAS deadline for confirming offers of 7<sup>th</sup> September 2022 (UCAS’s advisory deadline for higher education providers to hold places open for students).
